Reporting to the Medical Director, Medical, Laboratory and Stem Cell Services and/or the Associate Medical Director Laboratory Services, you will provide the clinically relevant direction and advice on all medical and technical laboratory services, policies and procedures in support of good manufacturing practices, all regulatory requirements, and will consult and collaborate with laboratory and medical colleagues regarding transfusion medicine practice and policy through the National Immunohematology Reference Laboratory at Canadian Blood Services.

### Responsibilities include:

- Providing medical expertise for the National Immunohematology Reference Laboratory
  - Provides professional, technical, scientific, consultative, organizational, administrative, and clinical support of the National immunohematology reference laboratory as well as associated quality assurance s and the supervision of tests and reporting of results.
  - Liaises with regional and national QA and with external QA organizations (for proficiency testing) with respect to nonconformances, root cause analysis and error reporting.
  - Supports provincial and Health Canada laboratory licensing/accreditation requirements
  - Provides advice to patients, physicians, Public Health authorities and other stakeholders regarding results of diagnostic laboratory testing.
- Assures ongoing communication between CBS, hospitals and prescribing physicians served by CBS with respect to matters that could affect medical practice.
- Promotes, initiates, and conducts applied and developmental research to optimize processes, services, and products, reduce costs, and evaluate new products or processes
- Participates in the development of CBS national and regional positions and policies with respect to immunohematology testing.
- Participates as a consultant to the Rare Blood Program.
- Participates on relevant national or regional medical committees requiring medical input.
- Provides consultative services and medical expertise to internal stakeholders at CBS.

### **Education, Training, and Experience Required:**

- A medical degree and a license in good standing to practice medicine in the province of Ontario is required.
- Must meet all relevant provincial requirements as defined in legislation and by accrediting bodies for Ontario.
- A specialty certification in Hematopathology, General Pathology, or Hematology with Transfusion Medicine training and at least 5 years' experience is required.
- Must have or be eligible for University appointment in Ontario.
